COMPANY DESCRIPTION:

Renaissance Minerals Limited (RNS) is an Australian-based gold exploration company. The Company's primary asset is the Okvau Project located in Cambodia, where drilling is ongoing with a view to expanding the current 1.2 Moz resource. Other assets include a large prospective ground holding in the Eastern Goldfields of Western Australia and early stage exploration targets in Alaska.

All amounts are in AUD unless otherwise noted.

DRILLING KICKS OFF AT OKVAU

Investment Perspective

Since the wet-season has now passed in Cambodia, Renaissance Minerals (RNS) has re-commenced drilling at its Okvau Gold Deposit, targeting the extensions to the north-west of the current resource, along with targeting the Area 1 and Rhyolite Ridge prospects. We continue to see the Okvau resource growing by approximately 100-200ozs following completion of this program due to increased confidence from previous RC drilling in the targeted area. Metallurgical test work on samples from the Okvau deposit is scheduled to begin shortly and should be a critical factor in determining the economic viability of the project. We maintain our SPECULATIVE BUY rating for RNS.

Investment Highlights

- Drilling has re-commenced at Okvau after the completion of the wet season in Cambodia. Initial drilling is targeting the north-east extensions of the Okvau deposit for which we estimate could add an additional 100 – 200koz to the current resource for Okvau. Previous RC drilling in this north-eastern area has returned positive results including 8m at 7.3 g/t Au (from 6m) and 9m at 9.3 g/t Au (from 37m). These intersections have not been included into the current resource and with additional infill drilling (currently underway) give us further confidence for the estimated additional ounces.
- Drill testing of Area 1, which lies ~3km north of Okvau, holds a significant gold-in-soil anomaly along the same interpreted gold corridor as Okvau. RNS plans to drill ~3,000m of RC to test this prospect for which no drilling has been done to date. Following the Area 1 drilling, RNS plans to test the Rhyolite Ridge target which is part of the Area 6 prospect.
- Over 700kg of drill core sample, from Okvau, has been received in Perth for detailed metallurgical test work. We see the results from this metallurgical program to be significantly important in terms of project economics for the Okvau Project.

Maintaining our SPECULATIVE BUY rating for RNS

We continue to see significant exploration upside to build upon the 1.25Moz gold deposit already defined at Okvau. With drilling now underway at Okvau and scheduled to begin shortly thereafter for the highly prospective Area 1 and Rhyolite Ridge, we continue to see upside risk from these 12 month share price lows and maintain our SPECULATIVE BUY recommendation.

INVESTMENT RISKS

The key investment risks for RNS include:

- **Geological risk** – Renaissance Minerals is a mineral exploration company, and there is no guarantee that exploration activities will result in the identification of an economic ore deposit. Furthermore, the actual characteristics of an ore deposit may differ significantly from initial interpretations and expectations.
 - **Financing risk** – the ability of RNS to fund the on-going exploration of its Cambodian, Australian and Alaskan projects should also be considered a key investment risk. Equity markets may not be conducive to raising the required funds to continue exploration activities at the Company's projects.
 - **Commodity price & exchange rate risk** – as with all mining and mineral exploration companies, commodity price and exchange rate risks should also be considered.

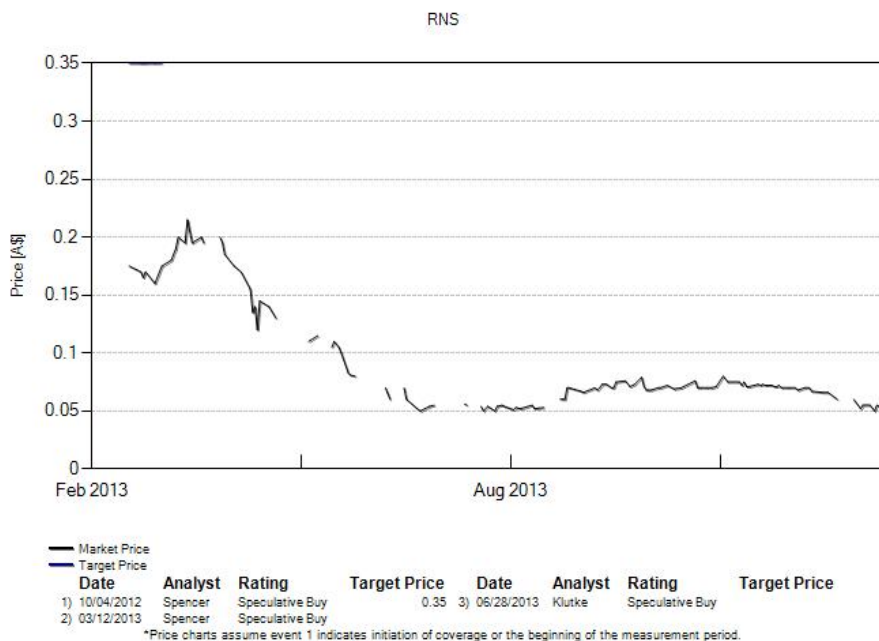
